The functions of Project monitoring Unit are as follows:

1. Monitoring the status of 2 Bed Room Housing Projects in the state.
2. To provide technical assistance/clarifications in execution, tendering process and in quality control.
3. Monitoring cement, steel and other material supply and requirements of the districts for speedy execution.
4. Preparation of financial proposals to the concerned department for getting assistance from State Government/Govt.of India/TSHCL as per the requests received from the District Collectors/Commissioner, GHMC on financial requirements for completion of projects and submit to Commissioner, Weaker Sections Housing Programme on forward to Government.
5. Maintaining periodical reports from the stage of sanction to completion of project/occupying by the beneficiaries and reporting Government time to time.
6. Coordinating with Municipal Administration and Urban development department and Government of India on Housing for All.
7. Monitoring and preparing a data base for all past housing schemes and beneficiaries and geotag/geofence the same to avoid duplication and double benefit to the same beneficiary in future scheme.

The Director, Weaker Section Housing Programme/ Managing Director, Telangana State Housing Corporation Limited, Hyderabad shall take necessary action accordingly.


