ORDER :

In the circumstances reported by the Commissioner, Weaker Section Housing Programme, Hyderabad in the reference 3rd read above and the note received vide reference 4th read above, the Government here by accord sanction for construction of 95,000 houses (1000 houses per each Assembly Constituency except GHMC area) in the State. The ratio between Rural and Urban areas shall be 240:160, if the constituency has both Rural and Urban areas for the above allocated 95,000 houses. The District wise distribution of Houses are as detailed in ANNEXURE appended to this order.

2. The funds available from PMAY(G) & "Housing For All" Schemes of Government of India shall be dovetailed to these 95,000 houses by the Housing Department. The entire programme in both Rural and Urban areas will be implemented in all the Districts by District Collectors.
3. The Commissioner, Weaker Section Housing Programme, Hyderabad is requested to approach the Government for release of subsidy from out of Budget Provision 2017-18 as and when the need arises depending on the pace of construction of the houses sanctioned above.
4. All the District collectors / Executive Directors, shall take necessary further action accordingly.
5. The Managing Director, Telangana State Housing Corporation Limited, Hyderabad shall take necessary action from sanctioning process to accessing the funds from the concerned funding agencies for completion of the above project in coordination with the District collectors / Executive Directors.
6. This order, issues with the concurrence of Finance Department vide their U.O.No.53/A2/EBS.X/2017, Finance (EBS.X) Department dated:1.4.2017.
